

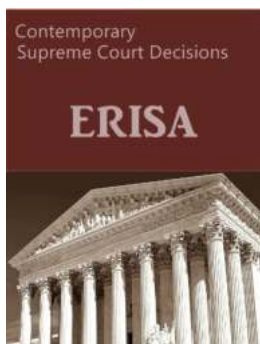

The Citizens United Case: Money as Speech

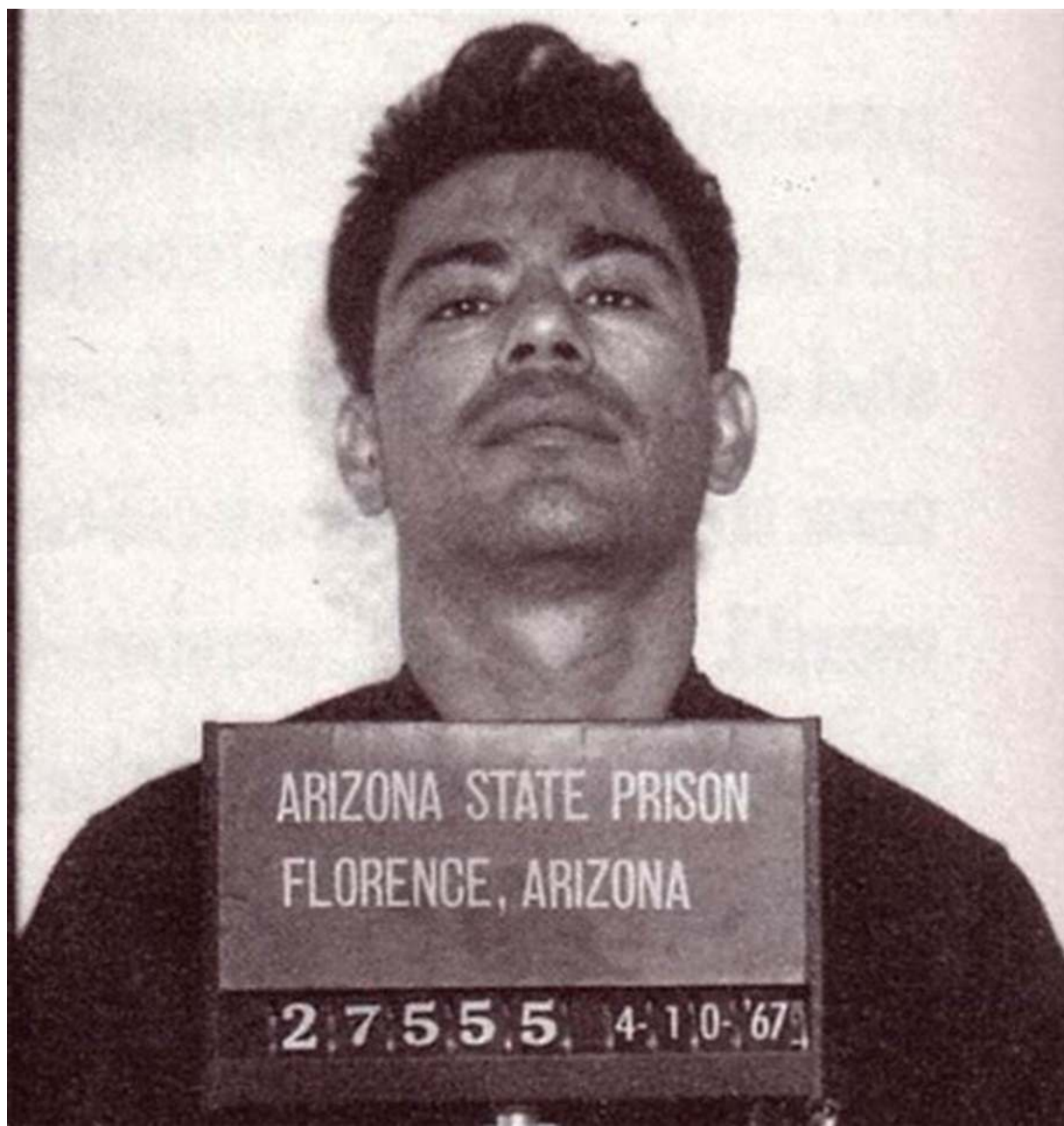
