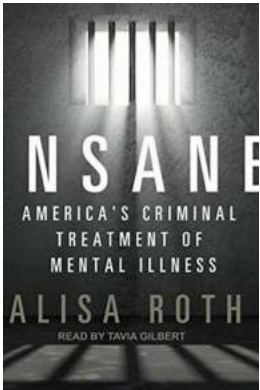

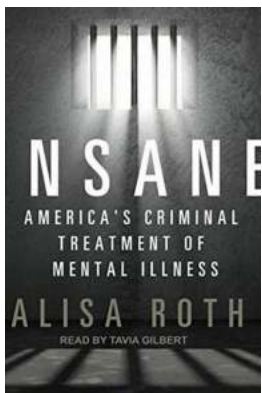
## **The Path to Reform**
