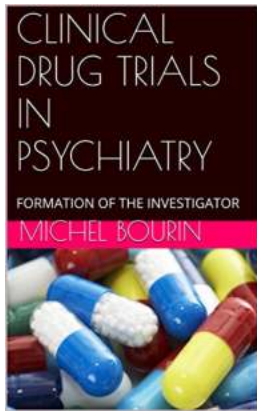

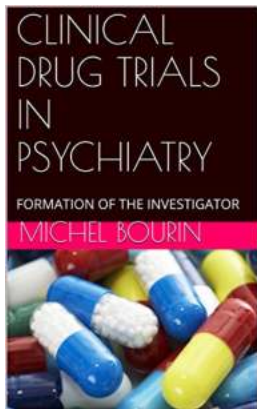

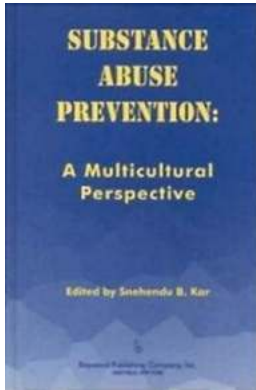
The essential purpose of this book is to consider in detail the different phases of drug development, which requires a knowledge of the prerequisites for drug
