

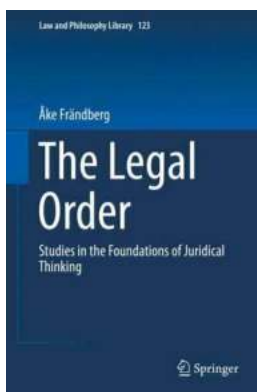

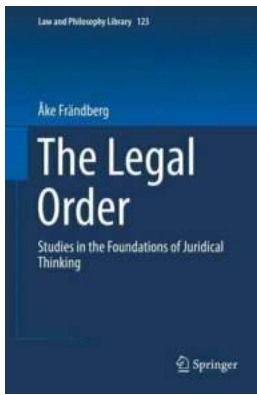

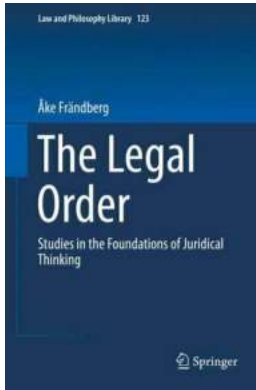

In this monograph a fundamental distinction is made between law and juridical thinking. Law is the content of legal rules and the systems of legal rules. 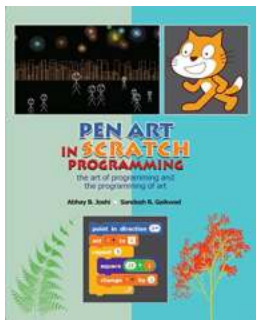

The work can be characterised as presenting a lawyer's philosophy of law.



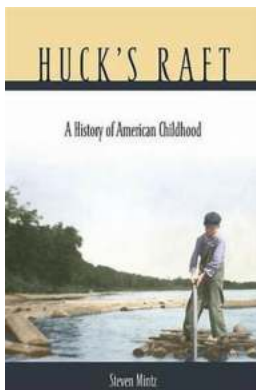

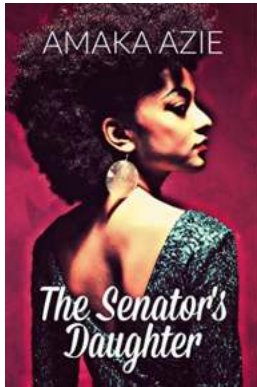
